## GRRAND VOLUNTEER RELEASE AND WAIVER OF LIABILITY

By signing below, I, \_\_\_\_\_ [print name], acknowledge that I am at eighteen (18) years of age or older (or, if I am not 18 or older, I have attached a signed parental waiver) and that I understand and agree to the terms and conditions of this GRRAND Release and Waiver of Liability (herein, the "Agreement").

This Agreement covers my participation as a GRRAND Volunteer in any GRRAND Activity, which includes, but shall not be limited to the following:

- a) Dog Walking
- b) Public & Fundraising Events
- c) Transportation of Dogs
- d) Home Visits
- e) Fostering
- f) Kennel Volunteer Work
- g) Vet Care Assistance
- h) GRRAND Affair Preparation Activities
- i) Dog Behavioral Evaluation

I acknowledge that my participation in GRRAND Activities is potentially hazardous. I further acknowledge that I understand that I should not participate in GRRAND Activities unless I am physically able and have been properly trained to do so. I agree to abide by any decision of the GRRAND Board of Directors regarding my ability to safely participate in GRRAND Activities. **I assume all risks associated with participating in GRRAND Activities including, but not limited to: falls, dog bites, dog attacks, infections, infestations, allergic reactions, or other accidents possible through the activity of walking dogs in neighborhoods, attending to them at public events, transporting them in my vehicle, or having other interactions with them.**

In consideration of allowing me to participate in GRRAND Activities or as a GRRAND Volunteer beginning on \_\_\_\_\_ 2\_\_\_\_ I, do hereby for myself, my heirs, my assigns, my executors and administrators expressly declare and agree as follows:

(1) That I hereby release and forever discharge GRRAND, members of the GRRAND Board of Directors, GRRAND officers, all persons, entities, and agencies involved with promoting or carrying out the day-to-day business of GRRAND, their agents, successors, representatives, and assigns and/or their heirs, executors and administrators, and also any and all other persons, associations and corporations, whether herein named or referred to or not, and who, together with the above named, may be jointly or severally liable to me, of and from any and all, and all manner of actions, causes of actions, rights, suits, covenants, contracts, agreements, judgments, claims and demands whatsoever in law or equity, including claims for contribution, arising from or by reason of any and all known and unknown, foreseen and unforeseen, bodily and personal injuries or death, damage to property, and the consequences thereof, relating to or arising from my participation in any GRRAND Activity or as a GRRAND Volunteer against .

(2) That I assume the risk of all bodily injuries, including death, resulting therefrom, and personal injuries, to me and damage to or loss of my property, including loss of use thereof and any other indirect or consequential damages, resulting directly or indirectly, wholly or in part, from my participation in a GRRAND Activity, as a GRRAND Volunteer or while traveling for any GRRAND event or business.

(3). That I hereby agree to indemnify, defend, and hold the entities specifically named in paragraph numbered 1 above harmless from and against any and all claims, liabilities, losses, damages costs, expenses (including attorney's fees), judgments and penalties arising out of any of my acts or omissions to act.

(4) That GRRAND, its members, and volunteers will not be held liable or legally responsible for my actions that constitute negligent or willful misconduct or misdeeds. I must notify GRRAND immediately if any such action occurs and any legal actions arising there from are my personal responsibility to defend, not that of GRRAND.

By signing below, I acknowledge and agree that I am not allowed to participate in any GRRAND Activities unless I sign this Agreement, and therefore I am receiving a benefit in exchange for signing this Agreement and it is binding on me. I acknowledge that I have read and understood this Agreement and I agree to its terms as consideration for, and as a condition of, my participation in any GRRAND Activity and as a GRRAND Volunteer. I further agree that this Agreement is also binding on my heirs, executors, administrators, legal representatives, and assigns.
